Dr. Howell shared that Rancho-Starbuck Intermediate School was named a 2013 Distinguished School. Each school in the District has now been named a California Distinguished School.

Dr. Howell was pleased to announce that the California Business for Education Excellence selected Macy Elementary, Meadow Green Elementary, and Rancho-Starbuck Intermediate School as 2012 Honor Roll Schools. In addition, Macy Elementary School and Rancho-Starbuck Intermediate School were recognized as “Scholar” schools and Meadow Green as a “STAR” school and “STEM” school. Dr. Howell explained that to be recognized as an Honor Roll school, the schools must have met a rigorous standard of increasing and sustaining grade-level proficiency.

Dr. Howell congratulated the fifth grade teachers at Macy Elementary School. Becky Champion, Rhonda Esparza, Kelly Higgins, and Julie Sigenfuse have all recently been selected by the Los Angeles County Office of Education to participate in the 2013 Colonial Williamsburg Teacher Institute for Early American History this summer.

Rancho-Starbuck Intermediate School seventh and eighth grade bands received a Superior rating at the Instrumental Music Festival. The Drum Line received first place in the Junior High School Division at the American Drum Line Association Finals. Mr. Jeremy Fletcher, Instrumental Music Teacher, and Mr. Cameron Miller, Drum Line Coach, are doing amazing work with their passion for music.

The 8th Grade Math Team from Rancho-Starbuck Intermediate School, under the direction of Mrs. Sylvia Behura, recently won a gold medal in Problem Solving at the Math Field Day sponsored by the Los Angeles County Office of Education.

Melanie Artz, the Art Teacher at Rancho-Starbuck Intermediate School, has been selected as an Outstanding Arts Educator for 2013 by Orange County Music and Arts Administrators and the Orange County Department of Education.

Mrs. Shackelford proudly announced that Meadow Green Elementary School is named as an Honor Roll School by the California Business for Education Excellence for the fifth year in a row. Additionally, Meadow Green was one of 100 schools in the state named as a designee for the STEM (Science, Technology, Engineering, and Math) Honor Roll. Congratulations Meadow Green! Meadow Green Elementary School raised over \$8,000 during the annual Meadow Green Dance-a-thon that was held on March 1, 2013. Proceeds from the fundraiser are going toward a new computer lab at Meadow Green. Appreciation and thanks are extended to all who helped us reach this goal. Open House at Meadow Green will be held on Tuesday, May 21, from 6:30 – 7:30 p.m. Science Fair projects will be displayed in the Multi-Use during Open House. Many field trips will take place in the month of May. Fourth graders will experience the *Walk through California* on site field trip and third grade will visit the Aquarium of the Pacific on May 24. Both Kindergarten and second graders are going to the LA Zoo on Friday, May 31. All trips are sponsored by the Meadow Green PTA.

Mr. Barber shared that Jordan Elementary School on Friday, May 10, at 11:00 a.m. will have its monthly Citizenship Assembly for the month of April. Jordan’s Open House and Spring Sing will be on Thursday, May 16, beginning at 5:45 p.m. Following the Spring Sing classrooms will be open for visitations. El Portal's annual Spring Fair will take place on May 31, from 3:00 p.m. – 7:00 p.m. It will be a family evening filled with carnival games, opportunity drawings, a silent auction, food, and fun.
